ANNOUNCEMENT OF PRE-REGISTRATION PERIOD

1. National Private Hire Vehicles Association intends to hold its inaugural branch general meeting for all its recognised branches* during the period of 30 March 2026 to 10 April 2026.
2. NOTICE IS HEREBY GIVEN that, in accordance with Clause 22(e) of the Constitution of National Private Hire Vehicles Association (hereinafter known as "NPHVA"), a Pre-Registration Period shall be applicable as follows:

Date: Monday, 29 December 2025 to Monday, 16 March 2026, 12pm

3. Ordinary Members who wish to attend, speak, vote or stand for election at the branch general meetings must fulfil the following eligibility criteria:
 - a. Continuous membership under NPHVA of at least 12 months without any outstanding membership fees
 - b. for Members who provide ride-hail services using bookable vehicles other than "Limousine"^,
 - (1) at least 1 task must have been performed within the last 2 months and 2 weeks of the Pre-Registration Period.
 - (2) in any continuous period of 30 days during the Pre-Registration Period, must have performed 100 or more tasks in the provision of any ride-hail platform services, out of which:
 - i. 50 or more tasks must be in the provision of ride-hail platform services with a platform operator which had accorded recognition to this Association under the Industrial Relations Act 1960, and is associated with the Branch to which the Ordinary Member belongs; and

- c. for Members who provide ride-hail services using “Limousine”[^], in any continuous period of 30 days during the Pre-Registration Period, have performed:
- (1) at least 1 task must have been performed within the last 2 months and 2 weeks of the Pre-Registration Period
 - (2) 10 or more tasks must be in the provision of ride-hail platform services with a platform operator which had accorded recognition to this Association under the Industrial Relations Act 1960, and is associated with the Branch to which the Ordinary Member belongs; and
- d. furnish during the Pre-Registration Period, **on or before 16 March 2026 12pm**, documentary proof of their fulfilment of the sub-rule above as the Executive Committee may require in its absolute discretion. Documentary proof will include, but is not limited to:
- (1) copies of valid Vocational Licences to drive bookable vehicles; and
 - (2) proof in the form of statements or job card screenshots from Trip History, from all Platform Operators that said member has performed jobs for, which shall state the total number of jobs completed across each platform operator during the pre-registration period.

These shall be submitted via email to NPHVA, titled “Proof of fulfilment of the sub-rule for Inaugural General Branch Meeting”
